3 Rapid Database Launch for First COVID-19 Vaccine Trial

In March 2020, Veristat partnered with a long-time client to urgently support a Phase I clinical trial for a novel coronavirus vaccine in the U.S. With just two pre-identified sites and 30 patients, the path to enrollment hinged on the rapid launch of the clinical trial database. Veristat provided full biometrics support—including project and data management, biostatistics, medical writing, and electronic submissions. Through a split-release strategy, the team built, tested, and launched the database in just 10 business days. This enabled immediate patient screening and dosing, with the first DSMB review occurring within weeks.
